Dear Sir/Madam,

With reference to your application dated 10-3-86, I write to convey sanction for Provisional Affiliation of the above-said school with the Board with effect from 1-5-86 to 30-4-90 for the All India/~~Board~~ Secondary School Examination. The school should abide by all the rules and conditions applicable to affiliated schools, as detailed in the Board's Hand Book for Affiliation of Institutions. The following are, however, specially brought to your attention :

1. The school shall appoint only qualified and eligible staff.
2. Service agreement be executed with the staff as per norms generally accepted by State Government. A copy of the same be sent to the Board.
3. Service conditions, Pay and allowances and other benefits to the employees of the school shall in no way be less than corresponding categories of employees working in Government schools of the State concerned.
4. The school will help the Board in the smooth conduct of the examinations by placing the necessary staff & accommodation i.e. Halls, Rooms available in the school premises and furniture at its disposal for holding the examinations free of charge, if required to do so.
5. The school shall remit Rs. 100/- as Annual Fee regularly by 31st March each year. A copy of the prescribed form for the same is also enclosed.
6. The school and its records shall be open for inspection by an official of the Board or any person authorised by the Board or the State Education Department at any time and the school shall furnish information as may be asked for by the Board/State Govt. from time to time.
7. The rate of tuition and other fees charged shall commensurate with the facilities provided.
8. The admission to the school shall be open to all without any discrimination on the ground of religion, caste or race, place of birth or any of them.
9. No unrecognised classes/branches shall be run within the premises of the school or outside in same name of school.

10. Reserve Fund be maintained in the joint names of the Chairman, CBSE and the school authorities in accordance with the enrolment in the school from time to time. The school shall provide adequate curricular and extra-curricular activities for the wholesome development of students.
11. The Code No. ^{already} allotted to your school is 05349. This may please be noted and quoted for any correspondence with the Affiliation Branch of the Board.

Your attention is also drawn to the specific conditions pointed out by the Inspection Committee or detected during the course of the inspection of the school which are given below :-

1. Two more labs be provided and be equipped with the list of equipments/apparatus published by the Board.
2. The pay scales and allowances be revised as to make them at par with the State Govt. by July 86, under intimation to this office.
3. Annual fee of Rs.200/- for the Academic years 1986-87 and 1986-87 be also submitted.
